How do I sign up?

Complete this form and return to your payroll coordinator.

Can I change it or cancel it at any time?

Absolutely! Just inform Payroll of your needs.

How do I benefit from pre-tax giving?

The tax calculated each pay will be done minus your donation. This means you pay less tax each pay. By receiving the tax benefit up front you won't need to wait until the end of the financial year. It makes handling your cash flow easier as well.

What is Workplace Giving?

Employee Workplace Giving donations are given through payroll in a pre-tax manner. You receive an instant tax refund with no need to keep receipts or wait until making your annual tax return claim.

How do my Workplace Giving donations help families with sick or injured children?

Your monthly Workplace Giving donation can provide:

- A "home away from home" at Ronald McDonald House for families travelling over 100km to receive hospital care for their sick or injured child.
- A place for families with sick children to relax, reconnect and spend precious time together at the Ronald McDonald Family Retreat.
