

Internet Privacy and Cookies Policy

At Nurseplus we are committed to safeguarding and preserving the privacy of our visitors. This Privacy Policy document explains what happens to any personal data that you provide to us, or that we collect from you whilst you visit our site and how we use cookies on this website.

We do update this Policy from time to time so please do review this Policy regularly

Information that we collect

In running and maintaining our website we may collect and process the following data about you:

- Information about your use of our site including details of your visits such as pages viewed and the resources that you access. Such information includes traffic data, location data and other communication data.
- Information provided voluntarily by you. For example, when you register for information or make a purchase.
- Information that you provide when you communicate with us by any means.

Recruitment Privacy Consent Statement

By submitting an application to us whether directly to the Recruitment Team, via our applicant tracking system or a referral you are authorising us to use your personal data provided to us, in relation to the role that you are applying for. You are also authorising us to hold your personal data within our candidate database for reference to future roles with Nurseplus, and to contact you regarding any such roles.

Any data submitted will be used for recruitment purposes, and any other sales or marketing activities which we feel would be relevant to you. As a candidate who has supplied their personal details you have the right to be forgotten. At any time you can therefore request, in writing, that your personal data be removed from our systems. If however, you commence employment with the Company, then we retain the right to decline any request to be forgotten, as we may need to retain your personal data for regulation purposes.

Right to be forgotten

If you contact us and request to be forgotten, we will endeavour to remove all of your personal information from our systems.

However, due to the nature of our business, there may be some instances where we are unable to delete all of your data, i.e. for regulation or audit purposes. If this is the case, we will advise you in writing of the circumstances restricting your deletion.

Use of Cookies

Cookies provide information regarding the computer used by a visitor. We may use cookies where appropriate to gather information about your computer in order to assist us in improving our website.

We may gather information about your general internet use by using the cookie. Where used, these cookies are downloaded to your computer and stored on the computer's hard drive. Such information will not identify you personally; it is statistical data which does not identify any personal details whatsoever.

Our advertisers may also use cookies, over which we have no control. Such cookies (if used) would be downloaded once you click on advertisements on our website.

You can adjust the settings on your computer to decline any cookies if you wish. This can be done within the "settings" section of your computer. For more information please read the advice at AboutCookies.org.

Use of your Information

We use the information that we collect from you to provide our services to you. In addition to this we may use the information for one or more of the following purposes:

- To provide information to you that you request from us relating to our products or services.
- To provide information to you relating to other products that may be of interest to you. Such additional information will only be provided where you have consented to receive such information.
- To inform you of any changes to our website, services or goods and products.

If you have previously purchased goods or services from us we may provide to you details of similar goods or services, or other goods and services, that you may be interested in.

We never give your details to third parties to use your data to enable them to provide you with information regarding unrelated goods or services.

Storing your personal data

In operating our website it may become necessary to transfer data that we collect from you to locations outside of the European Union for processing and storing. By providing your personal data to us, you agree to us transferring, storing and processing your data. All written personal data is stored in a locked cupboard within local branches and all data submitted online is stored within a secure server. We do our utmost to ensure that all reasonable steps are taken to make sure that your data is stored securely.

Unfortunately the sending of information via the internet is not totally secure and on occasion such information can be intercepted. We cannot guarantee the security of data that you choose to send us electronically, sending such information is entirely at your own risk.

Disclosing your information

We will not disclose your personal information to any other party other than in accordance with this

Privacy Policy and in the circumstances detailed below:

- In the event that we sell any or all of our business to the buyer
- Where we are legally required by law to disclose your personal information.
- To further fraud protection and reduce the risk of fraud.

Access to information
